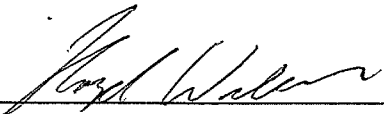
**WORKSHOP MEETING MINUTES**  
**AUGUST 7, 2026**

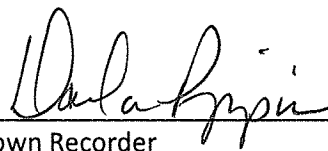
THE TOWN RECORDER DARLA PIPPIN, CALLED THE MEETING TO ORDER AT 2:00 P.M.
